With reference to your application dated 28-02-2024 and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to the

**Euro Global Academy School Class 1 to 8 for a period of three years:-
2024-25, 2025-26, 2026-27.**

The above sanction is subject to the fulfilment of the following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2009 (Annexure II).
3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker sections and disadvantaged groups in the neighbourhood and provide free and compulsory elementary education till its completion. Provided, further that in the case of pre-primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.

6. The School shall not deny admission To any child for lack of age proof. If such admission is sought after the extended provided prescribed for admission. On the grounds of religion, caste or race, place of birth or any of them.

7. The School shall ensure:

- (i) No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
- (ii) No child shall be subjected to physical punishment or mental harassment;
- (iii) No child is required to pass any board examination till the completion of elementary education;
- (iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 23
- (v) Inclusion of Students with disabilities/special needs as per provision of the Act
- (vi) The teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
- (vii) The salary and allowances payable to and the terms and conditions of service of teachers shall be as prescribed by the State Government under sub-rule(1) of rule(18) for the purpose of section 23(3) of the Act;
- (viii) The teacher performs its duties specified under section 24(1) of the Act and
- (ix) The teacher shall not engage himself or herself in private teaching activities.


8. The School shall follow the syllabus on the basis of the curriculum laid down by the appropriate authority.

9. The School shall enrol students proportionate to the facilities available in the school as prescribed in section 19 of the Act.

10. The School shall maintain the standards and norms of the school as specified in section 19 of the Act.
